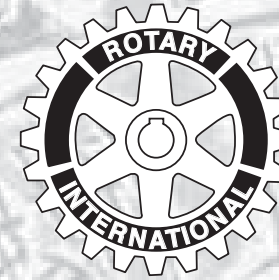

Section F: Drawing or Artist's Print: \$300 **Bernard Young and Associates**

CONDITIONS OF ENTRY

All fully completed entry forms must be completed and in the hands of the organizers by Friday 14 October 2011.

Late entries will NOT be considered for entry.

Only current original work by artists resident in Australia will be accepted.

All works will be presented for sale to the public at the price stated on the entry form.

The Organizers retain the right to not make an award when, in the opinion of the Judge, there is no work of a suitable standard in the particular section.

All award winning works will be available for sale to the public.

The Organizers will deduct 25% commission from all sales and the proceeds to the artists will be paid within 28 days of the close of the Art Show.

The Rotary Club of Appin Park Wangaratta is a charitable organisation and is not registered for GST. It neither charges nor claims GST

A non-refundable fee of \$10.00 per work must accompany the entry form and a maximum of five entries only will be accepted from any one entrant. Entries in Sections A,B,C and F can also be entered in Section E if appropriate.

Each work must be suitably framed, ready to hang and with name and address, sections entered and title clearly lettered and fixed to the back of the entry.

Any transport and insurance costs must be met by the artist. All possible care will be taken but no liability will be accepted by the organizers for any loss or damage to works of art.

If there is insufficient space to hang all entries the organizers reserve the right not to display some entries. However, all entries will be included in the judging.

Paintings, prints and drawings must not exceed 1.5 m in any direction. The work that receives the section E award shall also be eligible for the award for the section in which it is entered.

The Organizers reserve the right to photograph any entry for publicity purposes.

Visa and Mastercard facilities are available.
